OC Transportation Authority seeks community input on transportation needs

The Orange County Transportation Authority is conducting an online survey to gain better insight into how people living in Orange County are changing the way they get around the county.

The Transportation Needs Assessment Survey is intended to gauge people's opinions on the current public transit system and help shape future transportation planning in Orange County. [\[Continue here\]](#)

Caltrans identifies sites, many near freeways, for emergency homeless shelters

Small, undeveloped pieces of Caltrans property near freeway ramps and interchanges account for all but one of nine state-owned sites in Orange County identified Friday as spots where emergency shelters could be placed.

The one exception: the state-owned Fairview Developmental Center in Costa Mesa, where earlier this month only two residents remained in the cluster of buildings designed to hold hundreds of people with developmental and intellectual disabilities. [\[Continue here\]](#)

Revamped Calif. station to enhance pedestrian safety

State and local leaders joined SANDAG, the North County Transit District (NCTD), and Caltrans to celebrate the completion of the Poinsettia Station Improvements project with a ribbon cutting ceremony at the station's new underground rail crossing.

The Carlsbad Poinsettia Station improvements include new shelter enhancements, a pedestrian undercrossing, lengthened passenger platforms, fencing between tracks for added safety, and better customer amenities. The project broke ground in April 2018 and has improved regional train service, traveler times, and customer safety. [\[Continue here\]](#)

Here's What Happens When Public Transit Is Free

Candria Gray and her two children live in Worcester, Massachusetts, where they rely on city buses to get nearly everywhere: college classes, elementary school, the pediatrician's office. By 2017, when the Worcester Regional Transit Authority raised fares from \$1.50 per ride to \$1.75, Gray was spending as much as \$12 a day on transit — a good chunk of her budget as a single mom. New USDOT Infrastructure Grants

On February 19, USDOT published an invitation to apply for discretionary grant funding through the \$1 billion BUILD Program. These grants are for planning and capital investments in surface transportation infrastructure that will have a significant local or regional impact. BUILD funding can support roads, bridges, transit, rail, ports or intermodal transportation. Projects will be evaluated competitively based on: safety, economic competitiveness, quality of life, environmental sustainability, state of good repair, innovation, and partnership. 'The Survival of Our Region' Depends on Addressing Housing Crisis: A Q&A With Kome Ajise

Orange County cities have been pushing back on new regional quotas that significantly expand affordable housing goals for the next ten years, as the state puts pressure on them to address the housing shortage by zoning for new construction.

Uproar from some city officials started after the Southern California Association of Governments (SCAG) board — made of city and county elected officials — approved a draft plan in November to increase housing targets for certain cities in OC, like Newport Beach and Irvine. It stems from a state requirement that cities within the six-county region of SCAG zone for 1.3 million units of new housing over the next 10 years. [\[Continue here\]](#)

Paying for the Senate Highway Bill Would Require Additional \$102 Billion

Jeff Davis takes a closer look at the Congressional Budget Office's updated forecast of the Highway Trust Fund cash flow and the added cost of the Senate Environment and Public Works Committee's highway bill, S. 2302, introduced by Senator John Barrasso.

"That new CBO baseline estimates that over the next five years, the Highway Trust Fund will need about \$72 billion in new revenues or transfers in order to keep paying its bills, assuming current tax rates and the 2020 spending levels given annual inflation increases," says Davis. 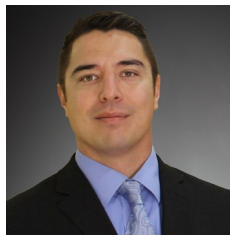

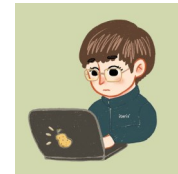
