Transit agencies in Orange, Riverside counties headed for showdown over 241, 91 toll lane connection

Caltrans recently received a 23-page letter from Riverside County transportation officials about all the things they think are wrong with plans for bridges that would let toll road drivers bypass lanes of traffic to get between the 241 and 91 freeways.

The state agency and toll road officials say they're taking seriously those concerns – also shared by Orange County's transit agency – as they decide whether to start designing the \$180 million ramps, but "as of now we are moving forward with the project," Caltrans spokesman David Matza said.

Riverside and Orange county officials fear solving backups on the 241 toll road will make things worse on the 91 – which many more drivers use – unless the fixes they're planning on the Riverside Freeway are done first. They also question traffic study data they say is too old and inconsistent. [Continue here]



California Energy Commission Doles Out Clean Transportation Grants

The California Energy Commission (CEC) has awarded more than \$6 million through its Clean Transportation Program, also known as the Alternative and Renewable Fuel and Vehicle Technology Program.

Two recipients received nearly \$1.3 million total for outreach, education and collaborative planning grants to accelerate the adoption of clean transportation in the San Joaquin Valley: The Fresno Metro Black Chamber Foundation will support the growth of several electric vehicle car-sharing and ridesharing services in disadvantaged communities, and Gladstein, Neandross & Associates LLC will support the deployment of clean medium- and heavy-duty transportation by facilitating access to incentives, providing technical assistance, and increasing engagement with operators and consumers. Uber and Lyft Caused Major Traffic Uptick In San Francisco, Study Says

Do ride-hailing companies like Uber and Lyft make a city's traffic worse or better? In San Francisco at least, the answer is decidedly worse, according to a newly published study in the journal Science Advances.

"It's by far the most detailed look that's been done in any given city," says Bruce Schaller, a transportation expert and former New York deputy commissioner for traffic and planning who was not involved in the study. "And it's certainly consistent with what we're seeing in other places." [Continue here]

City Dwellers Don't Like The Idea Of Congestion Pricing — But They Get Over It

New York City is preparing to become the first urban area in the U.S. to adopt congestion pricing — a fee for drivers entering the city center, designed to reduce gridlock and help fund the city's struggling subway system.

And nearly two years before the fees are put in place, a poll by Quinnipiac University found that 54% of New Yorkers are opposed to the change in policy. That's no surprise to experts on transportation policy. According to years of research, when a city prepares to adopt congestion pricing, residents are largely against the effort. But once the new charges are in place public opinion shifts, sometimes dramatically, in favor of the new reality. [Continue here]

U.S. Department of Transportation Announces Availability of \$60 Million for Advanced Transportation Technologies Grants

The U.S. Department of Transportation's Federal Highway Administration (FHWA) today published a Notice of Funding Opportunity (NOFO) for states, cities and other agencies to compete for \$60 million in Advanced Transportation and Congestion Management Technologies Deployment Program (ATCMTD) grants to fund new technologies that improve transportation efficiency.

"This program puts a priority on promoting innovative solutions that improve safety and mobility for our nation's drivers," said U.S. Transportation Secretary Elaine L. Chao.

Created in the "Fixing America's Surface Transportation" Act, the ATCMTD program works to improve the performance of U.S. transportation systems. The program funds early deployments of cutting-edge technologies that can serve as national models to improve travel for commuters and businesses. [Continue here]
