


September Presentation:  
**Riverside PACT: Holistic Active Transportation Planning**

The City of Riverside PACT consists of: a Pedestrian Target Safeguarding Plan (PTS), an Active Transportation Plan (AT Plan), a Complete Streets Ordinance (CSO), and a Trails Master Plan (TMP). These four plans will help the City create robust, sustainable and accessible transportation options and public spaces for residents and visitors well into the future.

### Ridership milestones on OCTA, MTA and Colorado transit systems

Several public transit service providers throughout the United States marked positive ridership milestones this past week. The gains were driven by students returning to class for the fall term, promotional fares and a deliberate, gradual return to service.

In California, Orange County Transportation Authority (OCTA) has achieved 100,000 average weekday riders for the first time since the start of the COVID-19 pandemic. OCTA says it has put an emphasis on the gradual, safe restoration of bus service, along with the implementation of programs that make riding the bus free for students and youth throughout Orange County.

### Caltrans Announces 45-Day Closures of 210 Freeway Roxford Street Ramps

The California Department of Transportation (Caltrans) announced a long-term closure of the westbound Roxford Street on and off-ramps to the 210 Freeway in Sylmar for paving work.

Residents and local businesses located near the 210 Freeway may experience noise, vibrations and dust associated with construction activities.

Crews are set to be closing Roxford Street on and off-ramps on the westbound 210 Freeway beginning Monday, Oct. 3, 2022 at 7 p.m. for up to 45 days.

### LA County plans \$15 million of bikeways, street improvements in South Whittier

Los Angeles County plans to spend \$15 million to build several bikeways and make road projects in unincorporated South Whittier.

Among the key benefits will be more access to the Norwalk-Santa Fe Springs Transportation Center that serves Metrolink, county officials said.

Such bicycle lanes are defined by pavement striping and signage to delineate a portion of a roadway for bicycle travel.

### Caltrain extension into downtown San Francisco could get a new name

In a region struggling to drum up support for new transit projects, the “Downtown Extension” doesn’t quite have the right ring to it.

That’s the conclusion of the agency in charge of the project to extend the Caltrain tracks 1.3 miles underground from the existing terminus at Fourth and King to a new station in the basement of the Salesforce Transit Center downtown. Instead, the Transbay Joint Powers Authority wants to rebrand the Downtown Extension as “the Portal,” in an effort to generate excitement and increase awareness about the project.

### Del Mar train tunnel plan advanced by San Diego Association of Governments

Danny Veeh, a senior planner at SANDAG said, “The seaside segment on the Del Mar bluffs has been a problem since the railroad was built,” he said. “Erosion eats away at the bluffs at the average rate of 4 to 6 in. a year, and presents a viable threat to public safety.”

According to the Del Mar Times, the state of California awarded San Diego County’s regional planning agency a \$300 million grant on Friday, Sept. 9, to move the train tracks off the Del Mar bluffs and to double-track the route between the San Dieguito Lagoon and Sorrento Valley.

Veeh said, “This is a momentous day. It’s larger than any other award that SANDAG has received to work on the LOSSAN corridor (the rail route from San Luis Obispo and Los Angeles to San Diego).” According to the Times, Veeh added that the 351-mile corridor handles \$1 billion in goods and 8 million passengers annually.

### Tesla's Full Self-Driving needs a driving test, and it's about to get one

Tesla's "Full-Self Driving" (FSD) driver-assist feature does not offer what its name promises.

Although Tesla CEO Elon Musk portrays the software as a prelude to fully autonomous vehicles, a quick online search shows videos of FSD-enabled Teslas in North America aiming straight at pedestrians, crashing into parked cars, and slowing down on a highway for no discernible reason. Unsurprisingly, more than a few observers have declared FSD to be a menace to traffic safety.

### Amtrak to Begin Cancelling Some Long-Distance Trains Tuesday

WASHINGTON (Reuters) - U.S. passenger railroad Amtrak will cancel trips on three long-distance routes starting Tuesday because of a potential freight rail strike later this week, and could be forced to cancel other trains.

Amtrak said it will begin suspending service for the Southwest Chief route from Chicago to Los Angeles, the Empire Builder route from Chicago to Seattle, the California Zephyr route from Chicago to San Francisco, and the Los Angeles to San Antonio portion of the Texas Eagle route starting Tuesday.

### Pressure mounts on US railroads, unions to reach a deal

Freight railroads and their unions are facing increasing pressure from business groups and the White House to settle their contract dispute before Friday's looming strike deadline.

The pressure stems from concerns that halting railroad deliveries of raw materials and finished products that so many companies rely on would be, in the words of the head of the U.S. Chamber of Commerce, an "economic disaster."

### How the Bipartisan Infrastructure Law Could Fast-Track Harmful Highway Boondoggles

The bipartisan \$1.2 trillion infrastructure deal signed into law in November 2021 has provided a previously near-unimaginable opportunity to invest in transportation in America. With more than half the funding made available under the new law going toward reauthorizing the surface transportation program, states now face a choice: spend this money to address dire needs with our transportation system, or squander it on wasteful boondoggle projects.

The federal dollars made available through the infrastructure deal could be spent on fixing our aging roads, making our streets safer, and making it easier to travel on transit, by bike or on foot, giving Americans real, viable options for getting around without having to drive.

Alternatively, they could be spent on building and expanding highways.
