Connected Vehicles

Speaker: Steve Mager (Traffic Technology Services)

Steve Mager is the Director of Government Accounts for Traffic Technology Services (TTS) and has been working in the software and technology sales for the past 10 years with a focus in the Traffic Industry for the last five.

TTS is a technology company and information provider for the automotive industry, commercial fleets, telematics integrators, and other transportation service providers. The patented core product, Personal Signal Assistant, utilizes existing public infrastructure and communication protocols



to provide data products for use in connected vehicle applications. TTS was recently mentioned as the provider for Audi's Traffic light information service that will be available starting this year with 2017 model year vehicles, continuing work the two companies have been demonstrating since the Consumer Electronics Show in 2014. TTS is actively deploying a nationwide V2I service, including the greater Los Angles metro area, and in Germany through its subsidiary TTS Europe.


U.S. DOT Issues Federal Policy for Safe Testing and Deployment of Automated Vehicles [CLICK HERE]

Four-Part Policy Lays the Foundation for the Next Revolution in Roadway Safety — The Federal Automated Vehicles Policy sets out a proactive safety approach that will bring lifesaving technologies to the roads safely while providing innovators the space they need to develop new solutions. The Policy is rooted in DOT's view that automated vehicles hold enormous potential benefits for safety, mobility and sustainability.

What is Vision Zero? [CLICK HERE]

Vision Zero is an approach to traffic safety, with an ultimate goal of ending traffic deaths and serious injuries. The idea began in Sweden in the 1990s, where they adopted it as national policy. At the core of Vision Zero is the belief that death and injury on city streets is preventable. For the most part, these aren't "accidents." Collisions are often the result of poor behaviors and unforgiving roadway designs. So we must approach the problem from multiple angles - street designs that emphasize safety, predictability, and the potential for human error, coupled with targeted education and data-driven enforcement efforts.




