Our January Program: M2 Environmental Mitigation Program By Dan Phu, OCTA

Happy New Year! Welcome back!

The first meeting of 2013 will feature a presentation about the **M2 Environmental Mitigation Program**. This Program is a major component of the sales tax measure to provide programmatic environmental mitigation to off-set impacts from the 13 freeway projects. This program involves integrating acquired open space properties and habitat restoration projects into a Natural Community Conservation Plan/Habitat Conservation Plan (NCCP/HCP). The NCCP/HCP also includes a public access component for the acquired properties and long-term land management by OCTA or its designee.



Dan Phu, OCTA:

Dan Phu joined OCTA as the Section Manager for the Project Development section to oversee the conceptual engineering/ planning documents for the Measure M2 (M2) freeway program. In 2009, he became the project manager for the M2 Environmental Mitigation Program. In Spring 2011, he took over the M2 Environmental Cleanup Program.

Prior to his tenure at OCTA, he was in the private sector at a local engineering firm preparing environmental documents and project reports. His previous accomplishments include leading the environmental document effort for the SR-22 high-occupancy vehicle lanes improvement project, which is currently in the final construction phase.


